LICENSE FOR ONE (1) WHMCS SERVICES INSTALLATION

This **EULA** is a **CONTRACT** between you and WHMCS Services which covers your use of the software product that accompanies this EULA. The software will be referred to herein as the "Software Product". A software license, issued to a designated user only WHMCS Services, is required for each user of the Software Product.

SOURCE CODE POLICY

1. You do not have the right to sell or give the source code without our (WHMCS Services) permission.
